THE FOUNDATION PROVIDES SIGNIFICANT FINANCIAL SUPPORT FOR CORE OPERATING AND ADMINISTRATIVE FUNCTIONS, ALLOWING A SUBSTANTIAL PORTION OF EXTERNAL DONOR CONTRIBUTIONS TO BE DIRECTED TOWARD PROGRAM DELIVERY AND YOUTH IMPACT.

DURING THE FISCAL YEAR, THE ORGANIZATION EXPERIENCED A PERIOD OF INTENTIONAL GROWTH AND CAPACITY BUILDING. INVESTMENTS WERE MADE IN FINANCIAL MANAGEMENT SYSTEMS, ACCOUNTING INFRASTRUCTURE, AND OUTREACH CAPACITY TO SUPPORT EXPANSION OF PROGRAMS AND ENSURE LONG-TERM SUSTAINABILITY. THESE INVESTMENTS ARE REFLECTED IN MANAGEMENT AND GENERAL EXPENSES AND ARE PART OF A STRATEGIC EFFORT TO SCALE PROGRAM IMPACT ACROSS COLORADO.

THE ORGANIZATION EXPANDED ITS RESILIENCE INITIATIVE FROM ONE PROGRAM TO THREE, INCLUDING: (1) HERO-WITHIN, WHICH PROVIDES INDIVIDUALIZED OPPORTUNITY GRANTS TO YOUTH DEMONSTRATING RESILIENCE; (2) BOUNCE BACK, WHICH SUPPORTS YOUTH ACTIVELY OVERCOMING ADVERSITY; AND (3) HUMAN-ANIMAL CONNECTION, WHICH ENGAGES YOUTH THROUGH THERAPEUTIC AND EXPERIENTIAL CONNECTIONS WITH ANIMALS.
